


#### **IMPORTANT**

- Device input port (J3) must either have a GuardLink® device or a Cat. No. 898D-41KU-DM2 shorting plug attached.
- Do not use more than seven Passive Power Taps on a link to avoid exposure to potentially harmful voltage.
- Product is fused to avoid damage from miswiring. We recommend using Allen-Bradley® patchcords to connect devices.
- Connect only one power supply to earth ground. You must choose the first power supply in the link.
- · Do not install tap while system is powered.
- For voltage drop calculation, see publication <u>440R-UM015</u>.


